Unless requested by the Chair of the Membership Committee, no Application or fee is required for rent-free use granted for less than seven days during any 12-month period.

- No dwelling is to be rented unless the lease is for at least one month.
- Seasonal residences shall not be rented during the off-season (November 1st to May 1st of the following year) and shall not be granted rent-free use in excess of six days during the offseason. (i.e. a Member's 60 days of off-season use privilege cannot be transferred to or used by another Member).
